### SHORT TITLE:

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO REJECT ALL RESPONSES TO RFP # FY 2022-2023-009 FOR ROADWAY RESTORATION AND REPAIR DUE TO FAILED NEGOTIATIONS WITH AWARDED VENDOR AND READVERTISE; REPEALING RESOLUTION 2023-065; AND PROVIDING AN EFFECTIVE DATE.**

## **STAFF SUMMARY:**

### **Summary:**

This agenda item seeks City Commission's approval to reject the bid submitted by Weekley Asphalt Paving, Inc., in response to RFP No. FY 2022-2023-009 - Roadway Restoration and Repair and as requested in Resolution 2023-065 due to the failed negotiations with the vendor.

### **Background:**

On May 1, 2023, the City released RFP No. FY 2022-2023-009 - Roadway Restoration and Repair. Weekley Asphalt, Inc. was the only responsive bidder.

On June 21, 2023, the City Commission passed Resolution 2023-065 authorizing the City Manager or his designee to negotiate the unit cost proposed by Weekley Asphalt Paving, Inc. in response to RFP No. FY 2022-2023-009 - Roadway Restoration and Repair (Exhibit 1).

### **Current Situation:**

Weekley Asphalt, Inc. submitted a price proposal on June 21, 2023. Staff reviewed the proposal and met with Weekly Asphalt, Inc. representatives on July 10, 2023 to negotiate the unit price presented in the proposal. Staff recommended lowering the unit price based on the fair market value. The representatives took note of the staff's price recommendations and concluded the meeting by promising to follow up with a counterproposal. Two weeks later, the team contacted the vendor, and the vendor stated they would not negotiate the price and would send us an email the following day, but they never did. At this juncture, staff deem Weekley Asphalt, Inc. unresponsive to the negotiations and will reissue a solicitation for roadway restoration and repair services.

### **Why Action is Necessary**

Pursuant to the City of Hallandale Beach Code of Ordinances, Chapter 23, Section 23-12, Procedures for purchases in excess of \$50,000, (4) Rejection of Bids, the City Commission may authorize City Manager to: a) Reject all bids; or b) reject all bids and re-advertise, pursuant to the procedure prescribed in this section in the Code.

### **Cost Benefit:**

By re-advertising, the City will be able to secure a lower unit price based on the fair market value. The performance of road rehabilitation limits the number of lawsuits and mitigates accidents citywide.

## **PROPOSED ACTION:**

City Commission to approve the attached Resolution.
