RESOLUTION NO. 2025 -**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA,
AUTHORIZING UTILIZATION OF THE STATE OF FLORIDA -
CONTRACT WITH CISCO TECHNOLOGY AUTHORIZED
VENDORS FOR ANNUAL CITY NETWORKING EQUIPMENT
AND SERVICES FOR A NOT TO EXCEED COST OF FIVE
HUNDRED THOUSAND DOLLARS (\$500,000); AND
PROVIDING AN EFFECTIVE DATE.**

14 **WHEREAS**, pursuant to Section 23-8(6) Bids and Contracts from other entities, and
15 Section 23-9. Cooperative purchasing, the City Manager is authorized to procure supplies,
16 materials, equipment and services pursuant to competitive bids and formal contracts of
17 other governmental units, and cooperative agreements, when the best interests of the City
18 would be served, subject to the requirement that any purchase in excess of \$50,000
19 requires City Commission approval; and

20
21 **WHEREAS**, the City of Hallandale Beach’s Innovation Technology Department
22 procures essential networking equipment and services annually to maintain a secure,
23 reliable, and up-to-date infrastructure; and

24
25 **WHEREAS**, the City’s core network is built on Cisco technology, which includes the
26 phone system, and over the past few years, all Cisco networking and phone system
27 equipment across City locations has been overhauled to improve connectivity, performance,
28 and security; and

29
30 **WHEREAS**, Cisco equipment requires ongoing software licenses, maintenance, and
31 periodic upgrades to ensure optimal functionality and security, and Staff recommends
32 cybersecurity upgrades, maintenance license renewals, redundant firewalls, professional
33 services, and Cisco switching equipment—all critical to sustaining the City’s network
34 resilience and security, which investments align with the City’s long-term technology
35 infrastructure goals for FY2024-2025 and beyond; and

37 **WHEREAS**, Staff recommends that procurement be conducted through vendors
38 listed on the State of Florida NASPO Authorized Subcontractor/Dealer/Reseller Information
39 Form Cisco Vendor List contract, ensuring competitive pricing and an efficient purchasing
40 process; and

42 **WHEREAS**, Staff recommends that the Mayor and City Commission find it to be in
43 the public interest to authorize utilization of the State of Florida - Data Communications
44 Products and Services - Contract No. 43220000-NASPO-19-ACS with Cisco technology
45 authorized vendors for annual City networking equipment and services for a not to exceed
46 cost of Two Hundred and Fifty Thousand Dollars (\$250,000) for each of fiscal years 2024-
47 25 and 2025-26, for a total not to exceed amount of Five Hundred Thousand Dollars
48 (\$500,000), and authorize the City Manager to execute relating documents.

50 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
51 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

53 **SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

55 **SECTION 2.** The Mayor and City Commission hereby authorize utilization of the
56 State of Florida - Data Communications Products and Services - Contract No. 43220000-
57 NASPO-19-ACS with Cisco technology authorized vendors for annual City networking
58 equipment and services for a not to exceed cost of Two Hundred and Fifty Thousand
59 Dollars (\$250,000) for fiscal year 2024-25 and fiscal year 2025-26 for a total not to exceed
60 amount of Five Hundred Thousand Dollars (\$500,000), and authorize the City Manager to
61 execute relating documents.

62 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
63 passage and adoption.
