A RESOLUTION OF CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE **BEACH COMMUNITY** REDEVELOPMENT AGENCY. HALLANDALE BEACH. FLORIDA; ADOPTING THE FINAL ESTIMATES OF REVENUE AND EXPENDITURES FOR THE FISCAL YEAR COMMENCING ON OCTOBER 1, 2023, AND ENDING ON SEPTEMBER 30, 2024 (FISCAL YEAR 2023-2024); APPROPRIATING THE FUNDS SHOWN THEREIN AS MAY BE NEEDED OR DEEMED NECESSARY TO DEFRAY ALL EXPENDITURES AND LIABILITIES OF THE HBCRA FOR FISCAL YEAR 2023-2024; APPROVING THE FISCAL YEAR 2023-2024 BUDGET; AUTHORIZING THE EXECUTIVE DIRECTOR TO TAKE ALL ACTION NECESSARY TO IMPLEMENT THE FISCAL YEAR 2023-2024 BUDGET; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in order to implement its Community Redevelopment Implementation Plan and provide for its operating expenses, the Hallandale Beach Community Redevelopment Agency ("HBCRA") prepared a Budget for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024 ("Fiscal Year 2023-2024"), in accordance with its Community Redevelopment Implementation Plan, as attached hereto as Exhibit "A" and made a part hereof (the "Fiscal Year 2023-2024 Budget"); and

**WHEREAS**, the Board of Directors of the HBCRA has determined that the Fiscal Year 2023-2024 Budget is in the public's interest and is necessary to implement the HBCRA goals and objectives, and desires to approve the Fiscal Year 2023-2024 Budget.

## NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:

Section 1. Recitals. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.

Section 2. Approval of Fiscal Year 2023-2024 Budget. The Fiscal Year 2023-2024 Budget for the HBCRA, as attached hereto as Exhibit "A" and made a part hereof, is hereby approved and adopted as the final and approved Fiscal Year 2023-2024 Budget for the financial operations of the HBCRA, and shall remain in full force and effect for Fiscal Year 2023-2024 including adoption of the final estimates of revenue and expenditures for Fiscal Year 2023-2024. Included in the Fiscal Year 2023-2024 Budget is a reconciliation of changes to capital initiative funding between Fiscal Years 2022-2023 and 2023-2024 as set forth on Exhibit "B".

Section 3. <u>Appropriation for Community Redevelopment Purposes</u>. The sums of money shown in Exhibit "A", or as much as may be needed or deemed necessary to defray all

50 51	Section 6. <u>Authority of Executive Director</u> . The Executive Director is hereby authorized to take all action necessary to implement the Fiscal Year 2023-2024 Budget.
