AS THE LOWEST RESPONSIVE BIDDER, IN THE AMOUNT OF ONE MILLION, EIGHT HUNDRED, NINETY-EIGHT THOUSAND AND TWO HUNDRED DOLLARS (\$1,898,200); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on July 22, 2024, the City released Bid # FY 2023-2024-07 16 inch Water Main Replacement on Atlantic Shores Blvd.; and
