16 **WHEREAS,** pursuant to Chapter 23, Section 23-4, City of Hallandale Beach
17 Code of Ordinances, purchases of and contracts for equipment, supplies and
18 contractual services, when the estimated cost shall exceed \$50,000, except as
19 specifically provided in that section, shall be based, wherever possible, on competitive
20 bids and pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager
21 shall have the authority to recommend to the City Commission award of contracts; and

23 **WHEREAS,** Staff seeks to replace an existing 12-inch watermain on Atlantic
24 Shores Blvd. with a new 16-inch watermain to run from NE 14th Ave. to Three Islands
25 Blvd., installing approximately 879 feet of the new watermain using horizontal
26 directional drilling technology to pass beneath the bottom surface of the De Soto
27 Waterway, and to install a new 8" PVC watermain, tee connections, gate valves, air
28 release valves, sleeves, and other water utility related work, and remove the existing
29 12" watermain; and

31 **WHEREAS,** on July 22, 2024, the City released Bid # FY 2023-2024-07 16
32 inch Water Main Replacement on Atlantic Shores Blvd.; and

34 **WHEREAS,** Staff recommends that the Mayor and City Commission find it in
35 the public interest to award Bid # FY 2023-2024-07 16 inch Water Main Replacement
36 on Atlantic Shores BLVD to JVA Engineering Contractor Inc. as the lowest responsive
37 bidder, in the amount of One Million, Eight Hundred, Ninety-Eight Thousand and Two

50 (\$1,898,200) and authorize a 10% contingency for a not-to-exceed amount of Two
51 Million, Eighty-Eight and Twenty Dollars (\$2,088,020), and authorize the City Manager
52 to execute all relating documents.
