4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
5 THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING
6 THE CITY MANAGER TO REJECT BIDS RELATING TO NO.
7 (RFP) # FY 2021-2022-001 DESIGN OF CHAVES LAKES PARK
8 AND ELECTRIC VEHICLE STATION; AND PROVIDING FOR AN
9 EFFECTIVE DATE.

12 WHEREAS, on October 13, 2021, the City of Hallandale Beach released (RFP) # FY 2021-
13 2022-001 Consultants' Competitive Negotiation Act (CCNA) Design of Chaves Lake Park
14 Environmental Center and Electric Vehicles (EV) Bus Station; and

16 WHEREAS, throughout the evaluation process, City staff continued to develop the
17 projects and explore alternative options for the EV bus charging station and reached the
18 conclusion that the EV Bus Charging Station should be developed and constructed at the current
19 Public Works compound, instead of at Chaves Lake; and

21 WHEREAS, pursuant to the City of Hallandale Beach Code of Ordinances, Chapter 23,
22 Section 23-12, Procedures for purchases more than \$50,000, (4) Rejection of Bids, the City
23 Commission may authorize City Manager to: a) Reject all bids; or b) reject all bids and re-
24 advertise, pursuant to the procedure prescribed in this section in the Code; and

26 WHEREAS, Staff recommends that the City Commission authorize the City Manager to
27 reject the bids from (RFP) # FY 2021-2022-001 so that the Chaves Lakes Park development and
28 Electric Vehicle Station at the Department of Public Works facility projects may be procured in
29 compliance with the City code separately.

31 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
32 THE CITY OF HALLANDALE BEACH, FLORIDA:

34 SECTION 1. Whereas Clauses. The foregoing "Whereas" clauses are incorporated
35 herein.

SECTION 2. City Manager Authorization. The Mayor and City Commission hereby authorize the City Manager to reject the bids from (RFP) # FY 2021-2022-001 so that the Chaves Lakes Park development and Electric Vehicle Station at the Department of Public Works facility projects may be separated and procured in compliance with the City code.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
