**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDDING INVITATION TO BID # FY2021-2022-003 LANDSCAPING IMPROVEMENTS ALONG HALLANDALE BEACH BOULEVARD TO ARAZOZA BROTHERS CORPORATION IN AN AMOUNT NOT-TO-EXCEED TWO HUNDRED TWENTY-TWO THOUSAND, ONE HUNDRED AND FIFTY-THREE DOLLARS (\$222,153); AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on September 30, 2019, City commission approved Resolution No. 2019-001 authorizing the City Manager to apply for a FDOT Beautification Grant for the improvement and beautification of seven (7) medians along Hallandale Beach Boulevard (between Interstate 95 and Federal Highway); and

**WHEREAS**, on December 4th, 2019, the Florida Department of Transportation awarded the City of Hallandale Beach a Landscaping Beautification Grant in the amount of One Hundred Thousand Dollars (\$100,000), which the City will match; and

**WHEREAS**, utilizing the Continuing Professional Architectural and Engineering Services RFP #FY 2013-2014-006, Craven Thompson and Associates, Inc., was selected to provide design services to include landscape plans, permitting and limited post design services; and

**WHEREAS**, pursuant to Code Ordinances, Chapter 23, Section 23-4, All purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000.00, except as specifically provided in this section, shall be based, wherever possible, on competitive bids; and

34           **WHEREAS**, following release of Invitation to Bid # FY2021-2022-003,  
35           Arazoza Brothers Corporation was the low bidder with a total base bid of Two  
36           Hundred Twenty-Two Thousand, One Hundred and Fifty-Three Dollars  
37           (\$222,153), and the request for additional funds of \$25,000 was authorized by the  
38           City Commission at its March 2<sup>nd</sup> Commission Meeting; and

40           **WHEREAS**, staff recommends the City Commission award Invitation to Bid  
41           # FY2021-2022-003, for the landscaping improvements project along Hallandale  
42           Beach Boulevard (between Interstate 95 and Federal Highway) to Arazoza  
43           Brothers Corporation in an amount not-to-exceed Two Hundred Twenty-Two  
44           Thousand, One Hundred and Fifty-Three Dollars (\$222,153), and authorize the  
45           City Manager to execute all related documents.

54           award Invitation to Bid # FY2021-2022-003 for the landscaping improvements  
55           project along Hallandale Beach Boulevard (between Interstate 95 and Federal  
56           Highway) to Arazoza Brothers Corporation in an amount not-to-exceed Two  
57           Hundred Twenty-Two Thousand, One Hundred and Fifty-Three Dollars  
58           (\$222,153); and authorize the City Manager to execute all related documents.

60           **SECTION 3. Effective Date.** This Resolution shall take effect immediately  
61           upon its passage and adoption.
