16	WHEREAS, pursuant to Chapter 23, Section 23-8 Exception to Bid
17	Requirements, (6) Bids and Contracts from Other entities, and Section 23-9
18	Cooperative Purchasing, the City Manager is authorized to procure all supplies,
19	materials, equipment and services from other governmental units, when the best
20	interests of the City would be served subject to the requirement that any purchase
21	in excess of fifty thousand dollars (\$50,000) requires City Commission approval;
22	and

24	WHEREAS, the City utility infrastructure is passed its life cycle of 50 years,
25	which has resulted in more frequent leaks and breaks requiring Staff to purchase
26	water meters, water meter fittings, and water line accessories for the day-to-day
27	repair and maintenance of the water distribution, stormwater, and wastewater
28	collection system; and
29	
30	WHEREAS, the Southeast Florida Governmental Purchasing Cooperative
31	allows the City to get discounts ranging from 10% to 83% on the retail price of a
32	variety of water meter fittings and water line accessories; and
33	
34	WHEREAS, the purchase of discounted water fittings and supplies is in the
35	interest of the City of Hallandale Beach, and

WHEREAS, staff recommends that the Mayor and City Commission
authorize utilizing the Southeast Florida Governmental Purchasing Cooperative
agreement entered into pursuant to ITB #: 2018- 19/12, through lead agency City
of Deerfield Beach, to purchase water fittings and supplies (a) from Core & Main
LP and (b) from Ferguson Waterworks in an combined amount not to exceed Three
Hundred Thousand Dollars (\$350,000).
NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE
CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
<b>SECTION 1.</b> The foregoing "Whereas" clauses are incorporated herein.
<b>SECTION 2.</b> The Mayor and City Commission hereby authorize utilizing the
Southeast Florida Governmental Purchasing Cooperative agreement entered into
pursuant to ITB #: 2018- 19/12 with the Southeast Florida Governmental
Purchasing Cooperative Group, through lead agency City of Deerfield Beach, to
purchase water fittings and supplies (a) from Core & Main LP and (b) from
Ferguson Waterworks in a combined amount not to exceed Three Hundred Fifty
Thousand Dollars (\$350,000); and authorize the City Manager to sign all related
documents.
<b>SECTION 3.</b> This Resolution shall take effect immediately upon its
passage and adoption.
