

## RESOLUTION NO. 2021 - 046

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE UTILIZATION OF THE CITY OF OAKLAND PARK'S AGREEMENT NUMBER R2019-070 FOR SANITATION CONSULTING SERVICES of KESSLER CONSULTING, INC. FOR AN AMOUNT NOT TO EXCEED THIRTY-NINE THOUSAND SIX HUNDRED FIFTY DOLLARS (\$39,650); AUTHORIZING THE CITY MANAGER TO SIGN ALL RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6) Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure all supplies, materials, equipment and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

**WHEREAS**, the City of Oakland Park's competitively bid RFP No. 032919 for Solid Waste Continuing Consulting Services resulted in a contract between Kessler Consulting, Inc. ("Consultant") and the City of Oakland Park dated July 1, 2019 (the "Source Agreement"), approved by the City of Oakland Park Resolution Number R2019-070; and

**WHEREAS**, the City utilized the Consultant to review sanitation services and prepare an RFP for multi-family and commercial collection; and

**WHEREAS**, Consultant is now being asked to revise the RFP document to also include the outsourcing of residential accounts, and, has submitted a change order to the existing scope of work to revise the RFP accordingly for an additional amount of seventeen thousand ninety dollars (\$17,090); and

35           **WHEREAS**, there is a current encumbrance with a balance of \$22,560, and  
36 the total revised scope of work amounts to thirty-nine thousand six hundred fifty  
37 dollars (\$39,650); and

39           **WHEREAS**, City staff recommends that the City Commission approve the  
40 requested change authorization for additional amount of seventeen thousand  
41 ninety dollars (\$17,090) to include outsourcing of residential accounts, so that the  
42 total not to exceed contract amount will be thirty-nine thousand six hundred fifty  
43 dollars (\$39,650).

46           **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE**  
47 **CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

49           **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

51           **SECTION 2.** The Mayor and City Commission hereby authorize the  
52 utilization of the City of Oakland Park's competitively bid RFP No. 032919 for Solid  
53 Waste Continuing Consulting Services with Kessler Consulting, Inc., and approve  
54 the requested change authorization for additional amount of seventeen thousand  
55 ninety dollars (\$17,090), so that the total not to exceed contract amount will be  
56 thirty-nine thousand six hundred fifty dollars (\$39,650); and authorize the City  
57 Manager to sign all related documents.

59           **SECTION 3.** This Resolution shall take effect immediately upon its  
60 passage and adoption.
