- b. Service Dog Education Campaign – Update – The City advised that a memo has been submitted, and is awaiting review and approval by the Commission, in order to carry out the campaign with the necessary resources for staffing and materials.
- c. Closed Sidewalks update – The city can only control City projects and has a protocol in place, which is being implemented, to ensure alternate access when a road and/or sidewalk is obstructed. Construction companies wanting to develop in the City are required to submit an MOT (Maintenance of Traffic) form that also addresses this. Let's make sure to send in photos if we see access blocked without signage.
- d. Paid On-Street Parking – Accommodations – We all agreed to let the actual street parking program settle the first year (or at least nine months), before submitting a request to add accommodation for caregivers. That said, if we hear about any particular hardship, let's submit it to the City to be addressed on a case-by-case basis.
