SUBJECT: The Amsterdam Restaurant Inc.

Staff has reviewed the police calls for service correlated to Amsterdam Restaurant Inc. located at 100 S. Federal Hwy, Hallandale Beach, between the time period of July 15, 2021 to May 3, 2022. During this time period, there were thirty-seven (37) police calls for service at that location. Three (3) of these police calls for service were violent in nature and were of concern to the Police Department. The first incident involved gunshots being fired at the business manager, the second incident involved an intoxicated patron who violently resisted arrest and the final incident involved the owner assaulting an employee. Despite these concerning incidents, the owner and management have been working with police staff to foster a good partnership and have dramatically reduced the calls for service within the past five (5) months. Therefore, at this time, the Police Department does not have any objections for the City to grant the establishment a 6:00 am license.

Currently, detail officers work at this establishment from 10:30 pm to 2:30 am. The Police Department requires one (1) police officer to work the detail from Monday to Wednesday and two (2) police officers from Thursday to Sunday. If this application were to be approved, the police department would require an extension of the police detail hours to 6:30 am.
