15	WHEREAS, Mr. and Mrs. Deza are property owners at 212 SW 7 th St, Hallandale Beach.
16	They filed suit against the City as it relates to the building of a pump station on the canal property
17	adjacent to the plaintiff's property; and
18	
19	WHEREAS, the Plaintiffs alleged unlawful taking and trespass and public nuisance during
20	the construction. The Plaintiffs also previously filed suit against the construction company
21	contracted by the City and the engineering firm that designed the project; and
22	
23	WHEREAS, the City has engaged in a precise strategic defense, including discovery and
24	fact-finding investigative preparation for trial; and
25	
26	WHEREAS, the parties met at court-mandated mediation and reach a settlement
27	agreement, subject to commission approval, at the amount of forty-nine thousand five hundred
28	dollars (\$49,500.00) as to Plaintiff's claims against the City; and
29	
30	WHEREAS, the Mayor and City Commission, being fully advised of the facts of this matter,
31	believe it is in the best interest of the City to resolve this litigation in lieu of proceeding to trial and
32	accepts the proposal for settlement.

34	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
35	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

37	SECTION 1. The foregoing "Whereas" clauses are confirmed as true and incorporated
38	herein.

40	SECTION 2. Approve Settlement. The Mayor and City Commission hereby authorize
41	the City Manager and City Attorney to settle litigation styled Nancy and Luis Deza v. City of
42	Hallandale Beach in Case No: CACE 20-008003 in the Circuit Court of The Seventeenth Judicial
43	Circuit, Broward County, Florida for the total sum of forty-nine thousand five hundred dollars
44	(\$49,500.00) in exchange for the execution of the appropriate release by Plaintiff and dismissal
45	of this case. Further authorizing the City Manager and City Attorney to execute any and all
46	necessary documents to effectuate the settlement of the case.
47	
48	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
49	passage and adoption.
