## **STAFF SUMMARY:**

### **Summary:**

This agenda seeks City Commission approval of the attached Resolution rejecting BID # FY 2021-2022-006 Hydrant and Valve Maintenance, Repair, Replacement and Flushing Services.

### **Background:**

The City of Hallandale Beach released BID # FY 2021-2022-006 on January 19, 2022. The intent of the BID was seeking interested and qualified firms who can provide hydrant & valve maintenance and replacement services, and flushing services for the City's water distribution system.

On March 10, 2022, the city received a response from one (1) vendor – R&M Service Solution.

### **Current Situation:**

The bid proposal submitted for this vendor is non-responsive because the proposing firm failed to complete a Bid Price Sheet with their submission.

Further review of the MQRs was not completed as the proposing firm is non-responsive.

Staff will re-release a new solicitation for bid soon after the City Commission approves the rejection of BID # FY 2021-2022-006.

### **Why Action is Necessary:**

Pursuant to the City of Hallandale Beach Code of Ordinances, Chapter 23, Section 23-12, Procedures for purchases more than \$50,000, (4) Rejection of Bids, the City Commission may authorize City Manager to: a) Reject all bids; or b) reject all bids and re-advertise, pursuant to the procedure prescribed in this section in the Code.
