11 WHEREAS, RFP # FY 2020-2021-007 Concession Services for Peter
12 Bluesten and OB Johnson Parks was released on August 18, 2021, to secure an
13 operator with experience and expertise to run the facilities without financial or
14 operational assistance from the City; and

16 WHEREAS, on June 1, 2022, The City Commission authorized the City Manager
17 to negotiate and execute a Lease agreement with the top ranked responder, Super
18 Duper Grub Hub; and

20 WHEREAS, City Staff believes it is not in the City's best interest to proceed with
21 contract negotiations at this time; and

23 WHEREAS, pursuant to City of Hallandale Beach Code of Ordinances, Chapter
24 23, Section 23-12, Procedures for purchases in excess of \$50,000, (4) Rejection of Bids,
25 the City Commission may authorize City Manager to: a) reject all bids; or b) reject all bids
26 and re-advertise, pursuant to the procedure prescribed in the Code; and

28 WHEREAS, Staff recommends that the Mayor and City Commission authorize the
29 City Manager to reject all bids and proceed in the best interests of the City, pursuant to
30 the procedures prescribed in the Code for RFP # FY 2020-2021-007 Concession Services
31 for Peter Bluesten and OB Johnson Parks.
