5 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
6 THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING
7 CITY TO SUBMIT A GRANT APPLICATION FOR THE U.S.
8 DEPARTMENT OF JUSTICE 2022 EDWARD BRYNE
9 MEMORIAL JUSTICE ASSISTANCE SOLICITATION GRANT
10 PROGRAM (JAG22) FOR FUNDING IN FISCAL YEAR 2022-
11 2023; PROVIDING FOR ACCEPTANCE OF THE GRANT
12 AWARD AND EXECUTION OF ALL DOCUMENTS; PROVIDING
13 FOR AN EFFECTIVE DATE.

14 WHEREAS, City Administration seeks authorization to submit an application to the U.S.
15 Department of Justice for the 2022 Edward Bryne Memorial Justice Assistance Solicitation Grant
16 Program (JAG22) for funding in fiscal year 2022-2023; and

18 WHEREAS, the JAG22, offered by the U.S. Department of Justice, is a program that
19 provides law enforcement agencies with resources to address a wide range of community and
20 department needs; and

22 WHEREAS, law enforcement agencies participating in the JAG22 receive funds pre-
23 determined by the Florida Department of Law Enforcement; and

25 WHEREAS, funding allocation is non-competitive, however, cities must still apply to
26 receive funding; and

28 WHEREAS, the City of Hallandale Beach applies for JAG funds annually. Per the
29 Program requirements, public notice must be made for acceptance of the grant. To fulfill this
30 requirement staff advertised via the Hallandale Beach Police Department's website to gather
31 information from the public; and

33 WHEREAS, the program also requires all applications be approved by the City
34 Commission and if so approved, JAG22 funding will become available during fiscal year 2022-
35 2023; and

37 **WHEREAS**, JAG22 funding will be utilized to purchase a vehicle hitched police smart
38 message board for the Police Department. The police smart message board will assist to
39 disseminate important information to public; and

41 **WHEREAS**, the Mayor and City Commission deem it to be in the best interest of the
42 citizens and residents of the City of Hallandale Beach to authorize City Administration to submit
43 a grant application for JAG22 as identified in "Exhibit A" attached hereto; and authorizing the City
44 Manager to execute any and all grant documents.

46 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
47 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

49 **SECTION 1.** The foregoing "Whereas" are incorporated herein.

50 **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby
51 authorize the submission of the grant application for the U.S. Department of Justice 2022 Edward
52 Byrne Memorial Justice Assistance Solicitation Grant Program (JAG22) for funding in fiscal year
53 2022-2023 as identified in attached "Exhibit A"; further authorize acceptance of grant application
54 award and the execution of any and all grant documents.

55 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its
56 passage and adoption.
