18	WHEREAS, the Agreement was amended on August 8, 2012 and on January 16		
19	2014, as approved by the City Commission in Resolution 2014-06; and

21	WHEREAS, the City has seen an increase in sanitation accounts each year and		
22	expects an additional 1,600 tons of waste for disposal for FY2020-21; and		
23			
24	WHEREAS, given the increasing annual solid waste disposals, City staff		
25	recommends that the City Commission authorize an increase to the annual maximum		
26	allotment for each of the remaining years of the current term to a not to exceed maximum		
27	of one million, five hundred thousand dollars (\$1,500,000) for the services of Progressive		
28	Waste Solutions of Florida, Inc., and authorize the City Manager to execute all relating		
29	documents.
