12 13	WHEREAS, pursuant to Chapter 23, Section 23-8 (6) Exception to bid
14	requirements, and Section 23-9 Cooperative Purchasing, the City Manager is authorized
15	to procure supplies, materials, equipment and services from other governmental units and
16	cooperatives, when the best interests of the City would be served; and

18	WHEREAS, on September 18, 2019, City Commission approved Resolution No.
19	2019-069, which authorized the City's piggyback of the Florida Municipal Power Agency
20	(FMPA) agreement with ENCO Utility Services, LLC; and

22	WHEREAS, on September 16, 2020, City Commission approved Resolution No.
23	2020-079, which authorized the City's piggyback of the Florida Municipal Power Agency
24	(FMPA) agreement with ENCO Utility Services, LLC; and

26	WHEREAS, the FMPA agreement with ENCO Utility Services, LLC is for an initial
27 1	period of five (5) years effective on the contract execution date of August 10, 2018 through
28	August 2023; and

30	WHEREAS, the City has reviewed various contracts for utility billing
31	printing/mailing services and find that piggybacking off the FMPA contract with ENCO
32	Utility Services is most cost effective for the City; and
33 34	WHEREAS, the Mayor and City Commission have determined that it is in the best
35	interest of the City of Hallandale Beach and its residents to piggyback the Florida

36	Municipal Power Agency contract with ENCO Utility Services, LLC for an amount not to
37	exceed One Hundred Twenty Thousand, Three Hundred Twenty-Five Dollars (\$120,325).

39	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY

46	Dollars (\$120,325). The City Manager is authorized to execute all related documents to
47	effectuate the project.
