14	WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach ("City")
15	Code, the City Manager shall have the authority to join with other units of government in
16	cooperative purchasing plans or to purchase pursuant to formal written contracts or
17	competitive bids of other governmental units, when the best interests of the City would be
18	served, subject to the requirement that purchases in excess of \$50,000 require City
19	Commission approval; and

21	WHEREAS, as a member of the U.S. Communities Government Purchasing
22	Alliance, the City is able to participate and utilize competitively solicited contracts to obtain
23	the best goods/services and pricing available in the market; and

25	WHEREAS, authorized City staff receive an electronic log-in to utilize the Amazon
26	contracted pricing to make purchases on-line. Some of the purchases made by
27	departments are electrical adapters, ethernet cables, laptop batteries, audio auxiliary
28	cables, drop cover cord protectors, fiber optic cables, heavy duty pad locks, and other
29	related items from Amazon Business On-Line Marketplace; and

31	WHEREAS, for FY 22/23, the total expenditures requested by departments for
32	Amazon Services, LLC Amazon Business On-Line Marketplace exceed the fifty thousand
33	(\$50,000) dollar threshold; and

35	WHEREAS, the Mayor and City Commission find that it is in the best interest of
36	the City of Hallandale Beach to authorize the utilization of the requested contract.
