**RESOLUTION NO. 2022-**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF  
THE CITY OF HALLANDALE BEACH, FLORIDA, ADOPTING THE  
CITY OF HALLANDALE BEACH 2022-2025 TITLE VI PROGRAM  
PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to 49 CFR Part 21, the U.S. the Department of Transportation (“FDOT”) requires implementation of Title VI of the Civil Rights Act of 1964 (‘Title VI,’) which prohibits discrimination on the basis of race, color, or national origin in programs and activities receiving federal assistance; and

**WHEREAS**, Federal Transit Administration (“FTA”) Circular 4702.1B provides guidelines for compliance with FTA Title VI requirements to transit agencies that receive assistance from the FTA; and

**WHEREAS**, pursuant to 23 CFR Part 200, the Federal Highway Administration (“FHWA”) provides guidelines for compliance with FTA Title VI requirements to transit agencies that receive assistance from the FTA; and

**WHEREAS**, the FDOT is a direct recipient of FHWA funds and provides funds to eligible local agencies that adopt Title VI nondiscrimination plans that comply with FHWA Title VI requirements and Florida nondiscrimination laws; and

**WHEREAS**, Broward County is a designated recipient of FTA funds and is a sub-recipient of FHWA funds from FDO and the City of Hallandale Beach is a designated sub-recipient of FTA funds and a sub-recipient of FHWA funds from DOT; and

**WHEREAS**, as Broward County has required the City of Hallandale Beach to submit a Title VI nondiscrimination program plan in compliance with 49 CFR Part 21, FTA Circular 4702.1B, 23 CFR Part 200, and Florida nondiscrimination laws, City Staff has developed the City of Hallandale Beach 2022-2025 Title VI Program Plan, in compliance with FTA, FHWA, FDOT, and Broward County requirements, for submission to Broward County; and

**WHEREAS**, the Title VI Program Plan will assure that no person shall on the basis of race, color, national origin, age, disability, family, or religious status, as provided by Title VI of the Civil Rights Act of 1964, and the Florida Civil Rights Act of 1992, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination or retaliation under any program or activity undertaken by the City of Hallandale Beach; and

**WHEREAS**, Broward County requires municipalities participating in the Community Shuttle Service Program to adopt by Resolution a Title VI nondiscrimination program plan in compliance with federal, state nondiscrimination laws; and

**WHEREAS**, Staff recommends that the Mayor and City Commission adopt the City of Hallandale Beach 2022-2025 Title VI Program Plan, in compliance with FTA, FHWA, FDOT, and Broward County requirements, for submission to Broward County.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1.** The Mayor and City Commission hereby adopt the City of Hallandale Beach 2022-2025 Title VI Program Plan, in compliance with FTA, FHWA, FDOT, and Broward County requirements, for submission to Broward County, and authorize the City Manager to execute any related documents.

**SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.
