10	WHEREAS, pursuant to 49 CFR Part 21, the U.S. the Department of
11	Transportation ("FDOT") requires implementation of Title VI of the Civil Rights Act
12	of 1964 ('Title VI,') which prohibits discrimination on the basis of race, color, or
13	national origin in programs and activities receiving federal assistance; and
14	WHEREAS, Federal Transit Administration ("FTA") Circular 4702.1B
15	provides guidelines for compliance with FTA Title VI requirements to transit
16	agencies that receive assistance from the FTA; and
17	WHEREAS, pursuant to 23 CFR Part 200, the Federal Highway
18	Administration ("FHWA") provides guidelines for compliance with FTA Title VI
19	requirements to transit agencies that receive assistance from the FTA; and
20	WHEREAS, the FDOT is a direct recipient of FHWA funds and provides
21	funds to eligible local agencies that adopt Title VI nondiscrimination plans that
22	comply with FHWA Title VI requirements and Florida nondiscrimination laws; and
23	WHEREAS, Broward County is a designated recipient of FTA funds and is
24	a sub-recipient of FHWA funds from FDO and the City of Hallandale Beach is a
25	designated sub-recipient of FTA funds and a sub-recipient of FHWA funds from
26	DOT; and
27	WHEREAS, as Broward County has required the City of Hallandale Beach
28	to submit a Title VI nondiscrimination program plan in compliance with 49 CFR
29	Part 21, FTA Circular 4702.1B, 23 CFR Part 200, and Florida nondiscrimination
30	laws, City Staff has developed the City of Hallandale Beach 2022-2025 Title VI
31	Program Plan, in compliance with FTA, FHWA, FDOT, and Broward County
32	requirements, for submission to Broward County; and

WHEREAS, the Title VI Program Plan will assure that no person shall on the basis of race, color, national origin, age, disability, family, or religious status, as provided by Title VI of the Civil Rights Act of 1964, and the Florida Civil Rights Act of 1992, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination or retaliation under any program or activity undertaken by the City of Hallandale Beach; and

WHEREAS, Broward County requires municipalities participating in the
 Community Shuttle Service Program to adopt by Resolution a Title VI
 nondiscrimination program plan in compliance with federal, state nondiscrimination
 laws; and

WHEREAS, Staff recommends that the Mayor and City Commission adopt
 the City of Hallandale Beach 2022-2025 Title VI Program Plan, in compliance with
 FTA, FHWA, FDOT, and Broward County requirements, for submission to Broward
 County.
