15	WILEDEAS the Building Division for the City of Hellendele Beach force
16	WHEREAS, the Building Division for the City of Hallandale Beach faces
17	many challenges. In addition to software upgrade requirements which were
18	delayed for many years, the City has for many years faced a staffing shortage; and
19	
20	WHEREAS, the City of Hallandale Beach does not currently have enough
21	plans reviewers, inspectors, and other personnel in-house to handle the high
22	volume of permit applications that are received on a daily basis; and
23	
24	WHEREAS, in order to supplement the number of building division
25	reviewers and inspectors that we currently have working with us, the City currently
26	utilizes outside agreements with both CAP Government, and Calvin Giordano &
27	Associates (CGA), respectively for building services such as plans reviews and
28	inspections. However, due to the shortage of skilled building personnel working for
29	those companies, it has been very difficult for us to access those contracts fully;
30	and

32	WHEREAS, the County maintains an Environmental Protection and Growth
33	Management Department, which includes a Building Code Services Division
34	("BCSD") that conducts building official, plan review, permit inspections, code
35	enforcement, and other services relating to building. pursuant to the "unique

circumstances" and can provide services to the City on a non-quaranteed basis pursuant to an interlocal agreement authorized pursuant to the unique circumstances exception to competitive bidding requirements in Section 23-8 of the City Code; and WHEREAS, the Mayor and City Commission find that that there are unique circumstances which warrant waiver of competitive bidding requirements and that it is in the best interest of the residents to authorize the proposed interlocal agreement with Broward County for Building inspection and other related services. NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA: **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein. **SECTION 2.** The Mayor and City Commission find that there are unique circumstances which warrant waiver of competitive bidding requirements and hereby authorize the interlocal agreement with Broward County for Building inspection and other related services in an amount not to exceed one hundred fifty thousand dollars (\$150,000) per year for the term of five years from FY 21/22 to FY 25/26 for a total contract value not to exceed seven hundred and fifty thousand dollars (\$750,000), and authorize the City Manager to sign all related documents. **SECTION 3.** This Resolution shall take effect immediately upon its passage and adoption.
