WHEREAS, the mission of the Hallandale Beach Community Redevelopment Agency ("HBCRA") is to promote economic development and enhance the quality of life by eliminating and preventing blighted conditions through the facilitation of community partnerships, business growth, job creation, and neighborhood rehabilitation; and

30 **WHEREAS**, the promotion of the Community Redevelopment Area and the use of tax 31 increment funds therefore falls within the purposes of the Community Redevelopment Act set 32 forth in Part III, Chapter 163, Florida Statues; and

WHEREAS, the procurement of the services of Florida International University in an amount not to exceed \$275,000 for the Food Network & Cooking Channel South Beach Wine and Food Festival including the Hallandale Beach Food & Groove event is permissible under Section 23-8(5) of the City of Hallandale Beach Procurement Code as a unique circumstances where the Board of Directors of the HBCRA finds unique circumstances to establish that competitive bidding is not in the best interest of the HBCRA; and

WHEREAS, the Board of Directors of the HBCRA desires to (a) approve the funding in an amount not to exceed \$275,000 to Florida International University for the Food Network & Cooking Channel South Beach Wine and Food Festival including the Hallandale Beach Food & Groove event, which events will, among others things, promote the Community Redevelopment Area, and

(b) authorize the negotiation, finalization and execution of an agreement with Florida International
 University for the Food Network & Cooking Channel South Beach Wine and Food Festival
 including the Hallandale Beach Food & Groove event in an amount not-to-exceed \$275,000.

46 NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS 47 49 OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:

- 48 Section 1. <u>Recitals</u>. The recitals in the whereas clauses are true and correct, and 49 incorporated into this Resolution.
- 50 Section 2. <u>Waiver of Competitive Bidding Due to Unique Circumstances</u>. Pursuant to 51 Section 23-8(5) of the City of Hallandale Beach Procurement Code the procurement of the 52 services of Florida International University in an amount not to exceed \$275,000 for the Food 53 Network & Cooking Channel South Beach Wine and Food Festival including the Hallandale Beach 54 Food & Groove event is permissible as unique circumstances exist and the Board of Directors of 55 the HBCRA finds that competitive bidding is not in the best interest of the HBCRA.

56 Section 3. <u>Approval of Funding</u>. The funding by the HBCRA in an amount not to exceed 57 \$275,000 to Florida International University for the Food Network & Cooking Channel South 58 Beach Wine and Food Festival including the Hallandale Beach Food & Groove event is hereby 59 approved.

Section 4. Negotiation and Finalization of Agreement. The Executive Director and HBCRA 60 Attorney are hereby authorized to negotiate and finalize an agreement with Florida International 61 62 University for the Food Network & Cooking Channel South Beach Wine and Food Festival including the Hallandale Beach Food & Groove events or, provided the funds are used for the 63 same purpose, its designee in an amount not-to-exceed \$275,000, which agreement will provide 64 that (a) Florida International University is authorized to make payments directly to its vendors and 65 (b) the Executive Director may authorize Florida International University to make direct payments 66 to certain vendors, all in connection with the administration, production and execution of the Food 67 Network & Cooking Channel South Beach Wine and Food Festival including the Hallandale Beach 68 Food & Groove event. 69

- Section 5. <u>Execution of Agreement</u>. The Executive Director is hereby authorized to
 execute the agreement with Florida International University for the Food Network & Cooking
 Channel South Beach Wine and Food Festival including the Hallandale Beach Food & Groove
 and the Goya Foods Fun and Fit events in an amount not-to-exceed \$275,000.
- Section 6. <u>Implementation of Agreement</u>. The Executive Director is hereby authorized to
 take all steps necessary and appropriate to implement the terms and conditions of the agreement.
- Section 7. <u>Allocation of Funds for Permit Fees and Personnel Costs</u>. An allocation of up
 to \$10,000 towards the costs associated with permit fees and City of Hallandale Beach personnel
 such as police and fire necessary to produce the events is hereby approved.
- 79 Section 8. <u>Effective Date</u>. This Resolution shall take effect immediately upon approval.
