A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE USE OF CONTINUING SERVICE AGREEMENT TO RETAIN THE SERVICES OF HAZEN AND SAWYER, P.C. TO DESIGN THE REVERSE OSMOSIS SKID PROJECT IN AN AMOUNT NOT TO EXCEED NINETY-SIX THOUSAND, NINE HUNDRED EIGHTY DOLLARS (\$96,980); AUTHORIZING THE CITY MANAGER TO SIGN ALL RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 5, 2020, the City Commission of Hallandale Beach adopted Resolution 2020-054 authorizing continuing service agreements solicited through RFP #2018-2019-012 — Continuing Professional Architectural and Engineering Services pursuant to Section 287.055, F.S., the Consultants Competitive Negotiation Act (CCNA); and

WHEREAS, effective December 15, 2020, the City of Hallandale Beach entered into its CCNA agreement with one of the selected design professional firms, Hazen and Sawyer, P.C. (Consultant), which permits the parties to execute Work Authorizations for specific City projects from time to time that do not exceed current CCNA statutory threshold amounts; and

WHEREAS, the City of Hallandale Beach owns, operates, and maintains the water treatment plant serving approximately 40,000 people within the City's corporate limits and seeks to continue utilizing City water for the longest extent possible by incorporating provisions to the existing water treatment plant that can accommodate higher salinity raw water; and

WHEREAS, to safeguard against future potential intrusion of saltwater into the CITY's wellfield, the City will install one reverse osmosis (RO) skid within the existing membrane treatment facility, capable of treating potential increasing saline raw water; and

36	WHEREAS, the preliminary opinion of probable construction cost for this			
37	project is \$3,650,000, below the statutory threshold; and
