13 (\$156,326.83); AUTHORIZING THE CITY MANAGER TO  
14 SIGN ALL RELATED DOCUMENTS; AND PROVIDING AN  
15 EFFECTIVE DATE.

18 **WHEREAS**, pursuant to Chapter 23, Section 23-4, City of Hallandale Beach Code of  
19 Ordinances, purchases of and contracts for equipment, supplies, and contractual services,  
20 when the estimated cost shall exceed \$50,000.00, except as specifically provided in that  
21 section, shall be based, wherever possible, on competitive bids Code of Ordinances, Code  
22 of Ordinances, Code of Ordinances; and

24 **WHEREAS**, on August 5, 2020, the City Commission of Hallandale Beach adopted  
25 Resolution 2020-054 authorizing continuing service agreements solicited through RFP  
26 #2018-2019-012 – Continuing Professional Architectural and Engineering Services pursuant  
27 to Section 287.055, F.S., the Consultants Competitive Negotiation Act (CCNA); and  
28

29 **WHEREAS**, the capacity of the current stormwater system is inadequate to manage  
30 the drainage of the Department of Public Works (DPW) compound in a manner that will  
31 allow for a safe operational area during heavy flooding events; and  
32

33 **WHEREAS**, Staff seeks to improve the drainage system at its DPW compound, and  
34 R. J Behar & Company submitted a cost proposal to complete the design for such drainage  
35 improvements in an amount not to exceed One Hundred Fifty-Six Thousand, Three  
36 Hundred Twenty-Six Dollars and Eighty-Three Cents (\$156,326.83); and
