Background Information - History of Road Paving Program

- 1989 – 2014: City budgeted for street rehabilitation with contributions from all funds as appropriate
- In 2014: City Street Maintenance Program was no longer on the 5-year CIP. The decision was made that individual streets were to be presented separately as CIP projects
 - City initiated Basis of Design Report (BODR)
 - The street rehabilitation program stagnated and for about 9 years only operational point repairs were made as needed
- Present day: Road Paving Program, a more wholistic approach, has been established

Road Restoration and Paving Program Update



Current Situation

- A total of 144,768 linear feet of road surface is planned to be resurfaced over the next 8 fiscal years
- Milling, resurfacing and restriping are included in the annual program
- Consideration of the condition of the infrastructure beneath the roads within this program will continue to be evaluated for replacement at the time the road surfacing is replaced
- The annual road paving and restoration estimated cost amounts on the subsequent slides are in current year dollars and will escalate in the future based upon economic conditions in future years
- Estimations, as a percentage of resurfacing costs, have been factored into the fiscal year cost estimates for mobilization (9%), traffic control (7%), pavement markings (2%), and contingency (15%) are included

Road Restoration and Paving Program Update



Proposed Approach - Quadrant Concept

- The quadrant approach ensures that the City is not focusing on just one area each year
- No two roads are alike, and each road has unique circumstances based upon age, traffic patterns, whether utility infrastructure resides underneath, etc. Each road in the program has been evaluated and preliminary estimation of repaving costs has been determined. Those costs are subject to change based upon the condition at the time of repaving and the bid amounts received for repaving

Timeline

- Response to RFP reviewed - June 2023
- Recommendation to City Commission by DPW - August 2023
- Contract proposed to be executed - September 2023

Proposed Approach - Quadrant Concept


RFP for FY 2022-2023-009 Roadway Restoration and Repair

- Evaluation Committee Meeting is scheduled for June 8, 2023, to review and evaluate responses to RFP
- Evaluation committee will rank proposals and select contractor(s) to perform restoration and repair work
- Contracts will be executed, and work will be prioritized by City staff, up to the budgetary amount of the annual appropriations.
- All appropriations will be funded by the General Fund for all fiscal years for roadway restoration and repair



CITY OF HALLANDALE BEACH




NW Quadrant


