20	Grant, CFDA 20.205 (contract ARF74) in the amount of three hundred twenty two thousand
21	(\$322,000.00) dollars was not included in the Schedule of Federal Awards ("SEFD); and

23	WHEREAS, this is a Federal Department of Transportation ("FDOT") program with funding
24	that is passed through to the State of Florida; and

27	tested and reported to the respective agencies on the SEFA in accordance with the Single Audit

29	WHEREAS the City must take appropriate action to guidit the program and include it in

31	the prior fiscal year SEFA; and
