### Short Title:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, REQUESTING THAT THE SHERIFF OF BROWARD COUNTY AND THE BROWARD COUNTY COMMISSION RESUME FUNDING OF THE SOUTH REGIONAL SATELLITE DETENTION FACILITY FOR BROWARD COUNTY PRISONERS; AND PROVIDING AN EFFECTIVE DATE.

### Staff Summary:

### Background:

With the Consensus of the City Commission, During the August 17, 2016 City Commission Meeting Mayor Cooper requested an item urging the Sheriff of Broward County and the Broward County Commission resume funding of the South Regional Satellite Detention Facility for Broward County Prisoners.

The Broward County Sheriff has been designated as the Chief Correctional Office for Broward County. On July 11, 2001 the City of Hollywood entered into an agreement with the Broward Sheriff's Office to provide remote booking services at the Hollywood Detention Facility and the City of Hollywood allowed its detention facilities to be utilized as a satellite reception center.

On October 17, 2012 the City Commission adopted Resolution 2012-331 which authorized the execution of Memorandum of Understanding (MOU) with the Sheriff of Broward County to resume funding of the South Regional Satellite Detention Facility for Broward County prisoners. This agreement was later terminated in 2013 and currently City officers transport prisoners to the main detention facility in Fort Lauderdale.

The operation of a detention facility in southern Broward County enhances the safety of Hallandale Beach residents by allowing City officers to transport a prisoner to a nearby facility and immediately resume their public service.

By approval of the attached Resolution, the Commission would approve the following:

1. Request that Sheriff of Broward County and Broward County Commission agree to resume funding of the South Regional Satellite Detention Facility for Broward County Prisoners.

**Why Action is Necessary:**

Pursuant to Article V, Section 5.01 of the City of Hallandale Beach Charter, a Resolution adopted by the Commission is an expression of the Commission on matters of official concern and opinion.
