

Since you removed the left lane to turn north you have created a traffic nightmare west bound it takes approx 3-4 light changes to get from US1 west of the tracks. I can't believe that we have that many Northbound turning vehicles that require that concern.

The light to advance west from US1 seems to be RED longer than the East bound light. Going to work at 12 noon its almost faster to turn left at US1 go south thru the many lights to get to Ives Dairy rd to get to I95. I don't think this was your plan when you implemented this light sequence.

Your assistance to remedy this problem would aid the residence of HB and its visitors. Traffic jams at this point will only be increased when the snow birds return to our city.

Thank you for your e-mail and follow-up phone calls. This e-mail acknowledges that AAF did coordinate with the City and FDOT on the design for modifications at the Hallandale Beach Boulevard crossing. You have requested the City of Hallandale Beach's "endorsement" of AAF's resulting plan. I have discussed the plan and AAF's request with the City Engineer and the City Manager's Office. The design as *originally* presented showed elimination of the *existing* WB to SB LTL. There was tremendous concern expressed by FDOT, if we recall correctly, that the elimination of a through lane to provide a *substitute* to replace the eliminated turn lane would be certain to have a large negative impact on the signalization and operating efficiency of the intersection. The alternative discussed was to keep the existing through lanes and entirely eliminate the option of a WB to SB turn, which the plan now reflects. The City acknowledges that there are competing interests involved in the decision and that the current plan prioritizes quiet zone safety improvements and through traffic volumes.

The City understands that Hallandale Beach is a State road and that the permitting will occur via FDOT. The City of Hallandale Beach, in order to *endorse* the revised plan, would seek the following:

- 1. An explanation of the impact of the original plan on signalization and intersection efficiency as compared to the revised plan's impact on the same.
- 2. Presentation of the plan at a public meeting in Hallandale Beach, with the City's assistance via provision of the venue and notice
- 3. A commitment to providing signage to indicate that access to south bound Dixie is possible via a series of right turns and signage warning that the existing left turn lane, for the remaining portion east of NE 1st Avenue, is a U-Turn lane only





This is great information, thank you. I will see that it is included in our specification.

Also, I do want to raise one important concern: when we met with Mariana to discuss our plans and construction, we reviewed a set of 90% plans which show that on Hallandale Beach Blvd we are planning to install a 10' traffic separator on the E side of the tracks. This is necessary in order to install a crossing gate to provide full coverage of the sidewalk and roadway. It does mean that there will be the loss of the centermost turn lane. While this was shown in the plans we discussed with Mariana, I want to be certain that the city understands that this is a design requirement and that we have no apparent alternative.

Florida East Coast Railway regularly upgrades the grade crossings in the City of Hallandale Beach, typically on a 7-10 year cycle per crossing. Does FECR currently file such a notice with the City? We would not necessarily object to doing so, but we do not want to deviate from what typically occurs when railroad crossings are resurfaced. Please confirm that such notice is normally requested of FECR during regular crossing work, and we will include it in our contract specification.

Also, please send us a list of special events that would be measurably affected by the temporary closure of a given roadway. Please specify which crossing is affected by that event. We have had productive feedback from other cities in this area and feel that a crossing-by-crossing matrix with the annual events that impact them is most useful for us to share with the contractor.

I am aware of the City's resolution of support for the project and am grateful for your enthusiasm. I look forward to working with you as we bring this project to fruition.

Thank you Michael. Understanding that the closures must be continuous and that the City will therefore want them to be completed as quickly as possible, please be aware that Hallandale Beach City Code states:

"The following is declared to be loud, disturbing and unnecessary noise in violation of City Code: Construction or repairing of buildings. The erection, including excavating, demolition, alteration or repair of any building or the excavation of streets and highways other than between the hours of 8:00 a.m. and 6:00 p.m. on any day except Sunday, when such activity shall be prohibited except in cases of urgent necessity in the interest of public health and safety.

Thus, the City will want the contractor to request in writing, at least 30 days in advance from the City Manager's Office, a finding of urgent necessity allowing for exceptions to the code restrictions as determined necessary, details to be coordinated at the time of request. We further will want closures within the City to 1) span over a weekend (Friday to Monday) whenever possible and 2) occur on dates that the City was allowed some input in determining to inform the contractor of special event conflicts that should be avoided (such as the annual Fun in the Sun Run that utilizes Pembroke Road.)

Not a problem, I am glad to respond to the request below. As we described in our meeting with Mariana, a typical crossing closure occurs over a continuous 55-hour period (103 hours for certain crossings). When a single crossing is worked on, it is typically closed from 10pm Friday to 5am Monday. Due to the scope of our project and the number of crossings that will be reconstructed, we must do some of our work on the weekdays and request any input the City has regarding the scheduling of this work so that we can pass it along to our contractors. The City will receive notice of intent to temporarily close a crossing 30 days before the crossing is closed, with a more general schedule being shared with you when we receive it from the contractor in early 2015.

The FECR has a major upcoming project of installation of additional rail (track). The 90% design plans are attached to this email.

The construction is scheduled for 2015 to 2016.

How exactly our City will be impacted:

- Pembroke Road, NE 3 Street, Hallandale Beach Boulevard, SW 3 Street, County Line Road will be completely closed during the construction
- Only one crossing will be closed at the time
- Hallandale Beach Boulevard and Pembroke road are scheduled to be completely for 103 hours (approximately 4.5 days)
- All other crossings are scheduled to be closed for 55 hours (approximately 2.5 days)


