A RESOLUTION OF MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING THE FIFTH AMENDMENT TO THE INTERLOCAL AGREEMENT RELATING TO DESIGN BUILD SERVICES FOR THE FOSTER PARK PLAZA AND PARKING LOT PROJECT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIFTH AMENDMENT TO THE INTERLOCAL AGREEMENT FOR DESIGN BUILD SERVICES FOR THE FOSTER PARK PLAZA AND PARKING LOT PROJECTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Hallandale Beach ("City") and the Hallandale Beach Community Redevelopment Agency ("HBCRA") previously entered into that certain Interlocal Agreement ("ILA") dated September 22, 2012, regarding the implementation of capital improvements projects funded by the HBCRA; and

WHEREAS, on May 19, 2014, the City and HBCRA entered into a First Amendment to the ILA for Project Management Services for the Parks Master Plan; and

WHEREAS, on August 5, 2015, the City and HBCRA entered into a Second Amendment to the ILA which set forth the provisions by which the HBCRA would secure all necessary financing for implementation of the O.B. Johnson Park project (the "Project"), with the City utilizing General Fund dollars in an amount not exceeding nine hundred thirty three thousand (\$933,000.00) dollars for interim financing of the Project; and

WHEREAS, on October 19, 2015, the City and HBCRA entered into a Third Amendment to ILA pursuant to which the HBCRA secured financing for the implementation of the Project with the City utilizing General Fund dollars in an amount not exceeding the total aggregate of \$2,952,740 for interim financing of the Project; and

WHEREAS, on November 19, 2015, the City and HBCRA entered into a Fourth Amendment to the ILA relating to the HBCRA issuance of its redevelopment Revenue Note, Series 2015 in an amount not exceeding \$15,400,000.00; and
