30	for FY 2016-2017 at .6600 mill, which is an 8.4% increase over the rolled-back rate of		
31	.6086 mill for the Three Islands Safe Neighborhood District.

33	SECTION 3. Approval of TISND Annual Budget. The Chair and Board of		
34	Directors hereby approve the annual budget submitted by the TISND for FY 2016-2017 a		
35	\$497,625 within the Three Islands Safe Neighborhood District.
