5 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
6 THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING
7 THE CITY MANAGER TO EXPEND FUNDS IN AN AMOUNT NOT
8 TO EXCEED ONE HUNDRED THOUSAND (\$100,000.00)
9 DOLLARS FOR TEMPORARY STAFFING FROM ALBION
10 STAFFING AS PROVIDED FOR IN THE FISCAL YEAR 2016-2017
11 BUDGET; AUTHORIZING THE CITY MANAGER TO EXECUTE
12 ALL RELATED DOCUMENTS TO EFFECTUATE THE
13 PURCHASE; AND PROVIDING AN EFFECTIVE DATE.

15 WHEREAS, pursuant to Chapter 23, Section 23=8 Exception to Bid Requirements, (6)
16 Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing, the City
17 Manager is authorized to procure all supplies, materials, equipment and services from other
18 governmental units, when the best interests of the City would be served subject to the equipment
19 that any purchase in excess of \$50,000 requires City Commission approval; and
20

21 WHEREAS, the City secures temporary staffing services from various vendors under the
22 NIGP SEFL Co-op Contract 13-D-140F (National Institute of Government Purchasing Southeast
23 Florida Cooperative); and

25 WHEREAS, the City utilized Albion Staffing to procure temporary staffing services when
26 necessary to fulfill the City's temporary staffing needs; and
27

28 WHEREAS, the City is desirous in utilizing the NIGP SEFL Co-op Contract 13-D-140F,
29 Albion Staffing for the for the City's temporary staffing needs for fiscal year 2016-2017; and
30

31 WHEREAS, City Administration anticipates expending one hundred thousand
32 (\$100,000.00) dollars for fiscal year 2016-2017; and

34 WHEREAS, the City Administration is requesting that the Mayor and City Commission
35 authorize the City Manager to expend funds for the procurement of Albion Staffing for temporary

36 staffing services for fiscal year 2016-2017 in the amount not to exceed one hundred thousand
37 (\$100,000.00) dollars.

39 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
40 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

42 **SECTION 1. Expenditure of Funds.** The Mayor and City Commission hereby authorize
43 the City Manager to expend funds for the procurement of Albion Staffing for temporary staffing
44 services for fiscal year 2016-2017 in the amount not to exceed one hundred thousand
45 (\$100,000.00) dollars, and authorize the City Manager to execute all related documents to
46 effectuate the purchase as provided for in fiscal year 2016-2017 budget.

48 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its
49 passage and adoption.
