20	investment advisor or similarly credentialed firm to monitor the City's investment portfolio
21	and investment policy; and

23	WHEREAS, on August 5, 2015, the City awarded RFP FY2014-2015-015
24	Investment Advisory Services to Public Financial Management ("PFM") Asset
25	Management, LLC; and

27	WHEREAS, on October 7, 2015, the City executed an agreement with PFM for a
28	one (1) year term and shall terminate on September 30, 2016, however the agreement
29	provides the parties the ability to renew the agreement for a one (1) year period for a total
30	of five (5) renewals, provided both the appropriation and availability of funds in accordance
31	with Florida Law; and

33	WHEREAS, the City Administration request authorization to execute an
34	amendment to the agreement with Public Financial Management (PFM) Asset
35	Management, LLC, renewing the original agreement for the period of one (1) year, in
36	substantially the same form as attached as Exhibit "A" and further request City Manager
37	authorization to execute any and all necessary documents to implement the service.; and

39	WHEREAS, the Mayor and City Commission have determined that the City
40	Administration's recommendations are in the best interest of the City and its residents.

48	further authorize the City Manager to execute any necessary documents to implement the
49	service.
