A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, ACCEPTING THE RECOMMENDED NOMINEES OF THE HALLANDALE BEACH HISTORICAL PRESERVATION BOARD RICHARD ALLEN AND FRAN MARKOWITZ FOR THE 2016 HALLANDALE BEACH PIONEER RECOGNITION AWARD.

Staff Summary:

Background:

From 1973 to 2014, the Broward County Historical Commission held an annual event honoring Broward County Pioneers. The Broward County Historical Commission Pioneer Day Recognition Ceremony honored individuals that are living pioneers within Broward County. After the 2014 event, the Broward County Historical Commission discontinued the Pioneer Program.

On December 16, 2015, the City Commission adopted Resolution 2015-164 establishing the Hallandale Beach Pioneer Recognition Program. The Hallandale Beach Pioneer Recognition Program recognizes an individual each year that is a living pioneer within the City of Hallandale Beach.

The resolution provides that the Historic Preservation Board will make their final recommendations to the City Commission.

Once approved by City Commission, the recipients will be honored and recognized at the November 14, 2016, City Commission meeting, with a reception prior to the meeting, and will be presented with a Proclamation.

Current Situation:

The Hallandale Beach Historic Preservation Board sought nominees for the 2016 Hallandale Beach Pioneer designation and obtained completed Pioneer Nomination and Biographical Information Forms for?Richard Robert Allen and Fran Markowitz.

Mr. Allen has worked for the City of Hallandale Beach Police Department for thirty seven (37) years and has served the community as a member of the American Legion. He is a 37-year resident of the City.

Ms. Markowitz is a forty four (44) year resident of the City of Hallandale Beach and has served the community as a member of the Historic Preservation Board and Rotary Club of Hallandale Beach/ Aventura.

The Historic Preservation Board unanimously voted to recommend both nominees to the City Commission for consideration.

Why Action is Necessary:

City Commission approval of the Historic Preservation Board 2016 Pioneer nominee recommendation.

Fiscal Impact:

Proposed Action:

Staff recommends the City Commission to approve the Resolution approving the Historic Preservation Board recommendation naming Richard Allen and Fran Markowitz the 2016 Hallandale Beach Pioneers.
