17 18	WHEREAS, since June 1, 2012, Security Alliance LLC has provided the
19	security services to the GISND. Security Alliance secured the contract after a successful
20	bid; and
21	WHEREAS, the current contract between the City and Security Alliance, LLC is for
22	a term of three (3) years with two (2) one (1) year extensions. The original term expired
23	on October 1, 2015 and the contract was extended for one year until October 1, 2016; and
24	
25	WHEREAS, the Golden Isles Safe Neighborhood District (GISND) currently has a
26	uniformed security guard posted at the Layne Boulevard guardhouse twenty-four (24)
27	hours a day, three hundred sixty-five (365) days a year, and also a marked security vehicle
28	rover patrolling the District every night of the week for a total of forty (40) hours per week;

31	WHEREAS, on August 17, 2016, Security Alliance LLC accepted the second one
32	(1) year extension to the contract and requested a permitted cost adjustment of two
33	percent (2%) of the annual contract amount justified by the rise in insurance costs,
34	specifically worker's compensation, general liability and auto: and
35 36	WHEREAS, the GISND Advisory Board has continuously demonstrated their
37	support for the services provided by Security Alliance, LLC; and
38	WHEREAS, Security Alliance, LLC has provided exceptional security services to
39	the GISND, and have provided a prompt response to any requests and/or concerns; and
