21	WHEREAS, on June 13, 2016, the City released Request for Proposal (RFP) for the
22	Golden Isles Tennis Center Operations RFP #FY2015-2016-018 via electronic mail to fifty-three
23	(53) vendors from the City's Vendor's list and other media outlets; and

25	WHEREAS, on June 23, 2016, a non-mandatory pre-proposal conference was held and
26	two (2) prospective firms attended; and
27	
28	WHEREAS, on July 6, 2016, in response to the solicitation, the City received a single
29	response to the request for proposal from Todd Trombetta Tennis Academy; and
30	
31	WHEREAS, the Evaluation Committee conducted an evaluation process, to review the
32	minimum qualification requirements for the proposed firm. After the initial review and ranking, the
33	single responding firm was ranked as the highest qualified proposed firm; and
34	
35	WHEREAS, the first step in this process will be the award of the RFP by the City
36	Commission. The second step will entail city staff negotiating with Todd Trombetta Academy for
37	a preconstruction and operation and management agreement to be brought back for City
38	Commission acceptance; and
