RESOLUTION NO. 2016 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO PIGGYBACK ON THE CITY OF FORT LAUDERDALE RFP #855-11487 TO PROCURE TEMPORARY BUILDING PLAN REVIEW AND BUILDING INSPECTION SERVICES FROM CALVIN GIORDANO & ASSOCIATES, INC. IN AN AMOUNT NOT TO EXCEED ONE HUNDRED EIGHTY EIGHT (\$188,000.00) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PROJECT AS NEEDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6) Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing the City Manager is authorized to procure all supplies, materials, equipment and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

WHEREAS, the Development Services Department, Building Division has the necessity to supplement inspection and plan review staff in order to adequately service its customers; and

WHEREAS, due to the recent increase in workload and the departure of two field inspectors, the Building Division is seeking to procure the services from Calvin Giordano & Associates, Inc. through RFP #855-11487 with the City of Fort Lauderdale, for plan reviewers and inspectors; and

WHEREAS, to date, the City has issued purchase order in an amount of forty-nine thousand dollars (\$49,000.00) to Calvin Giordano & Associates, Inc.; and

WHEREAS, based on present need, this amount will quickly be exhausted, creating the need to obtain City Commission approval to extend the limit of spending beyond what the City Manager is authorized to expend; and

40 **WHEREAS**, in an effort to avoid stoppage of services to the customers, the
41 Division is proactively seeking Commission approval; and

43 **WHEREAS**, the City Administration has determined that it is in the best interest of
44 the City and its residents to utilize the piggyback of the City of Fort Lauderdale RFP #855-
45 11487 in an amount not to exceed one hundred eighty eight thousand (\$188,000.00)
46 dollars to procure staffing services from Calvin Giordano & Associates, Inc. for inspection
47 and plan review staff in order to adequately service its customers.

49 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
50 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

52 **SECTION 1. City Manager's Authorization.** The Mayor and City Commission
53 hereby authorize the City Manager to piggyback on the City of Fort Lauderdale RFP #855-
54 11487 in an amount not to exceed one hundred eighty eight (\$188,000.00) dollars to
55 procure staffing services from Calvin Giordano & Associates, Inc. for inspection and plan
56 review staff in order to adequately service its customers, and further authorizing the City
57 Manager to execute all documents necessary to effectuate the expenditure of funds for
58 the project.

60 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon
61 its passage and adoption.
