Commission Chambers

1. CALL TO ORDER

Mayor Cooper called the meeting to order at 6:33 PM.

2. ROLL CALL

Present: 5 - Mayor Cooper, Vice Mayor Julian, Commissioner Lazarow, Commissioner London and Commissioner Sanders

City Manager Rosemond and City Attorney Whitfield were present as well.

3. PLEDGE OF ALLEGIANCE

4. PUBLIC PARTICIPATION (Speakers must sign-in with the City Clerk prior to the start of the meeting)

City Clerk Bataille read into the record an email communication received by Joy Adams in support of Vice Mayor Julian.

Alex Lewy, 212 NE 3rd Street Unit 12, Hallandale Beach, FL, congratulated Commissioner Lazarow and Commissioner Elect Taub for their victory during the 2016 Election. Mr. Lewy recommended the City Commission adopt legislation which would band corporate contribution in City Elections and support campaign finance reform.

Coach Ed DeLeon, 1000 Parkview Drive, Unit 118, Hallandale Beach, FL, thanked the City for accommodating the swimming program held at Peter Bluesten Park by allowing them access to B.F. James pool while Peter Bluesten Park closes for construction. Coach DeLeon hoped the program would continue at Peter Bluestein Park while the YMCA operates the park.

Elizabeth De Souza, 1040 SW 66th Avenue, Hollywood, FL, spoke in support of a potential future sponsorship between the YMCA and Hallandale Beach Swim Team/Program.

Tara Weatherall, 305 SW 7th Court, Hallandale Beach, FL, thanked the City for accommodating the swimming program held at Peter Bluesten Park by allowing them access to B.F. James pool while Peter Bluesten Park closes for construction.

Mayor Cooper along with the City Commission presented Larry Blustein with a Proclamation for his induction into the 2016 Broward County Sports Hall of Fame and for his positive impact on the community.

Asha Loring, Executive Director of Health in the Hood, provided an update on the Hallandale Beach Community Garden and answered questions posed by the City Commission.

D. VICE MAYOR JULIAN

A motion was made by Vice Mayor Julian, seconded by Commissioner Sanders, to hold the scheduled November 28, 2016 Organizational Meeting on December 7, 2016. The Motion failed by a 2/3 Voice Vote. Commissioners Lazarow, London, and Sanders cast the dissenting votes.

E. MAYOR COOPER

A motion was made by Mayor Cooper, seconded by Commissioner Sanders, to reappoint Alexander Lewy to the Police and Fire Pension Board. The motion carried by a 4/1 voice vote. Commissioner Lazarow cast the dissenting vote.

Commissioner London indicated while he voted yes on the Motion to appointment of Mr. Lewy to the Police and Fire Pension Advisory Board he plans to bring the Motion back for reconsideration by the Commission in a future meeting as he opined the Motion is inappropriate as it would preempt the newly elected Commissioner from voting on the Motion.

Mayor Cooper announced the City has received its tax distribution from the State.

Mayor Cooper shared changes made to the actural assumptions for the City's pension, where the assumption rate has been reduced from 7.75 to 7.50.

Mayor Cooper shared information from the Greater Fort Lauderdale Alliance (GFLA) Economic Source Book which showcase the City of Hallandale Beach individual strengths and cost of living.

Mayor Cooper requested staff to look into whether there is any flexibility within the Fire Code with respect to decimal level requirement for condominiums.
