

The City Attorney also serves as the City's advocate in Arbitration proceedings, and Administrative Tribunals, and serves as Municipal Prosecutor. The City Attorney quickly solves problems and overcomes obstacles to advance the success of the City by concentrating in the practical day to day hands on to meet deadlines, work within established budgets, create, formulate, communicate and implement strategies and objectives with proactive follow through to ensure success.
