24	City Commission adopt as the City's priorities for either legislative support or opposition
25	as listed in Exhibit "2" and incorporated herein by reference to be presented to the
26	Legislative Delegation; and

28	WHEREAS, the City also requests funding assistance to control/mitigate the beach
29	erosion severely impacting its coastal residents; and funding assistance for the
30	construction of an additional water supply well in the Biscayne Aquifer; and

33	Administration, the City's lobbyist, and the legislators in pursuing legislation which address
34	these priorities and other related matters on behalf of the City and its residents; and
