5 A RESOLUTION OF THE MAYOR AND CITY COMMISSION
6 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
7 ADOPTING THE CITY'S 2017 LEGISLATIVE PRIORITIES
8 TO BE PRESENTED TO THE BROWARD COUNTY STATE
9 LEGISLATIVE DELEGATION FOR CONSIDERATION
10 DURING THE 2017 LEGISLATIVE SESSION; AND
11 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, annually, the City Commission discusses various issues for submittal
15 to the Broward County Legislative Delegation and State Legislators for consideration
16 during the legislative session; and
17

18 **WHEREAS**, as there are many issues that are significant to the City, it is imperative
19 to prioritize those issues that are most important and to focus its energy in ensuring the
20 constituent voices are heard at the County and State levels; and

22 **WHEREAS**, the City Administration has reviewed prior priorities and the current
23 needs of the City and based on this year's discussions recommend that the Mayor and
24 City Commission adopt as the City's priorities for either legislative support or opposition
25 as listed in Exhibit "2" and incorporated herein by reference to be presented to the
26 Legislative Delegation; and

28 **WHEREAS**, the City also requests funding assistance to control/mitigate the beach
29 erosion severely impacting its coastal residents; and funding assistance for the
30 construction of an additional water supply well in the Biscayne Aquifer; and

32 **WHEREAS**, these priorities serve to guide the City Commission, City
33 Administration, the City's lobbyist, and the legislators in pursuing legislation which address
34 these priorities and other related matters on behalf of the City and its residents; and

36 **WHEREAS**, the City Administration recommends that the Mayor and City
37 Commission adopt the proposed City of Hallandale Beach's 2017 State Legislative
38 Priorities attached as Exhibit "2".

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Commission Adoption of City's 2017 State Legislative Program and City Manager Authorization. The Mayor and City Commission hereby adopts the City of Hallandale Beach 2017 State Legislative Priorities as listed in Exhibit "2" as being in the best interest of the City and its residents and further authorize the City Manager to take the necessary steps to cause a copy of this resolution to be forwarded to the Broward County Legislative Delegation and State Legislators for consideration during the 2017 legislative session.

SECTION 2. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
