30	the CRA, and installation of traffic box wraps has been completed for the traffic boxes; and

33	application; and
34	WHEREAS, the City Administration recommends authorization to accept and approve the
35	final wraps that the HBCRA approved at the May 16, 2016 Board of Directors meeting; and
