22	MULEDEAC the City and DDU Decelorally Decelorally LLC ("DDU") entered into an
23	WHEREAS, the City and PRH Beackwalk Beachclub, LLC ("PRH") entered into an
24	Operating and Management Agreement ("the agreement") for the redevelopment and operation
25	of the City's North Beach Park and its restaurant; and
26	WHEREAS, PRH having engaged in a highly competitive process, the Operator proposes
27	to replace the current Restaurant Operator with Beach-Chu Hallandale LLC, an affiliate of Azumi
28	Limited ("Azumi"), the company behind the highly successful Zuma and ROKA restaurants; and
29	WHEREAS, Azumi is an award winning global restaurateur with sixteen (16) locations
30	offering a sophisticated twist on the traditional Japanese style of informal eating; and
31	WHEREAS, PRH is requesting the City approve Beach-Chu Hallandale, LLC, and affiliate
32	of Azumi Ltd. ("Beach-Chu") as operator of the restaurant at the North City Beach Park Building;

34	WHEREAS, the new restaurant, Bi-Chu Beach, is inspired by Azumi's ROKA concept and
35	brings a similar restaurant dining style and vitality to the beachside setting of Halladale Beach;

67	SECTION 1. City Manager's Authorization. The Mayor and City Commission hereby
68	authorize the City Manager to execute Amendment #1 to the Operating and Management
69	Agreement with PRH Beachwalk Beachclub, LLC. PRH-2600 Hallandale Beach LLC, for Beach-
70	Chu Hallandale LLC, an affiliate of Azumi Ltd as the subcontractor to operate the City's North
71	Beach Park Restaurant including additional proposed amendments as provided in Exhibit "5".
72	Further authorizing the City Manager to execute an assignment of the restaurant operation to
73	Beach-Chu Hallandale LLC, an affiliate of Azumi Ltd; and that the City Manager be authorized to
74	execute the necessary documents and establish accounts need to fulfill this purpose and to
75	effectuate the project.

77	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
78	passage and adoption.
