L9	WHEREAS, on January 25, 2017, the City Commission approved Resolution 2017-06
20	awarding RFP # FY2015-2016-025 CCNA Design Service Pumps and Transfer Pumps at the
21	City's Water Treatment Plant to Hazen and Sawyer, Inc.; and
22	
23	WHEREAS, Resolution 2017-06 authorized the City Manager and the City Attorney to
24	negotiate an agreement with Hazen and Sawyer and to bring back for City Commission approval;
25	and
26	
27	WHEREAS, the scope of work to be provided shall include the design, permitting,
28	assistance with bidding and construction oversight assistance for the replacement of the high
29	service pump stations (HSPs); and
30	
31	WHEREAS, the design, permitting, assistance with bidding and construction oversight
32	assistance was budgeted in Fiscal Year (FY) 2015-2016 in the amount of four hundred thousand
33	(\$400,000.00) dollars; and
34	
35	WHEREAS, the preliminary construction costs are estimated to be two million seven
36	hundred thousand (\$2,700,000.00) dollars. However, the necessary funding has been divided
37	over the course of Fiscal Year 2016-2017 in the approved budgeted amount of one million, three
38	hundred-fifty thousand dollars (\$1,350,000.00) dollars and for Fiscal Year 2017-2018 a budget

39	request subject to City Commission approval will be submitted in an amount of one million, three
40	hundred-fifty thousand (\$1,350,000.00) dollars; and

42	WHEREAS, the City Administration recommends the City Commission authorize the City
43	Manager to execute an agreement with Hazen and Sawyer, Inc. for the scope of services provided
44	in Exhibit 4 for design and permitting of the Water Treatment Plant High Service Pumps Phase I
45	in an amount not to exceed Three Hundred Ninety-Nine Thousand, Nine Hundred Forty-Nine
46	(\$399,949.00) dollars.

48	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
49	THE CITY OF HALLANDALE BEACH, FLORIDA:
50 51	SECTION 1. City Manager's Authorization. The Mayor and City Commission hereby
52	authorize the City Manager to execute an agreement with Hazen and Sawyer, Inc. for the scope
53	of services provided in Exhibit 4 for design and permitting of the Water Treatment Plant High
54	Service Pumps Phase I in an amount not to exceed Three Hundred Ninety-Nine Thousand, Nine
55	Hundred Forty-Nine (\$399,949.00) dollars. Further authorizing the City Manager to take all
56	necessary to effectuate the project.

58	SECTION 2. Effective Date. This Resolution shall take effect immediately upon its
59	passage and adoption.
