4 5 6 7 8 9 10 11 12 13 14 15 16 17	A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE CITY OF POMPANO BEACH RFP E-13-17, UNLEADED GASOLINE AND DIESEL FUEL FOR THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING COOPERATIVE GROUP CONTRACT WITH PORT CONSOLIDATED, INC. TO PROCURE UNLEADED GASOLINE AND DIESEL FUEL AS BUDGETED FOR IN FISCAL YEAR FY2016-2017; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PROJECT AS NEEDED; AND PROVIDING AN EFFECTIVE DATE.
18	WHEREAS, pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements,
19	(6) Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing the
20	City Manager is authorized to join with other units of government in cooperative
21	purchasing to procure supplies, materials, equipment and services, when the best
22	interests of the City would be served, subject to the requirement that any purchase in
23	excess of \$50,000 requires City Commission approval; and
24	
25	WHEREAS, the Public Works Department-Fleet Maintenance Division, is
26	responsible for providing fuel for all City vehicles in the Fire, Police, Code Compliance,
27	Parks and Recreation, Human Services and Public Works Departments; and
28	
29	WHEREAS, Public Works is also responsible for tracking and ordering, when
30	necessary, the diesel and unleaded fuel inventory for all of the City generators, all lift
31	stations, and the underground tanks located at the Department of Public Works
32	Compound; and
33	
34	WHEREAS, the City of Hallandale Beach is a Participating Agency in the
35	Southeast Florida Governmental Purchasing Cooperative Group (Co-Op); and
36	
37	WHEREAS, the City participates in the Co-Op Group in order take advantage of
38	cost savings that a city of this size would otherwise be unable to realize; and
39	

40	WHEREAS, the current piggyback contract with MacMillan expires March 31,
41	2017, and the city requires a new contract for the purchase of fuel; and
42	
43	WHEREAS, the City of Pompano, acting as the lead agency for approximately
44	forty five (45) other agencies in this Co-Op procurement, released RFP E-13-17, Unleaded
45	Gasoline and Diesel Fuel for Southeast Florida Governmental Purchasing Cooperative
46	Group, on December 20, 2016. The RFP closed on January 20, 2017, and was followed
47	by an evaluation committee selecting Port Consolidated, Inc. for award; and
48	
49	WHEREAS, on February 28, 2017, the City of Pompano adopted an ordinance on
50	1st Reading awarding RFP E-13-17 to Port Consolidated, Inc. for the purchase of diesel
51	fuel and has scheduled 2 nd Reading for March 14, 2017; and
52	
53	WHEREAS, on March 15, 2017, or soon thereafter an executed contract will be
54	made available online on the co-op contract page. The term of the contract is for three
55	(3) years and includes an option to renew for two (2) additional two (2) year terms; and
56	
57	WHEREAS, the Mayor and City Commission find that it is in the best interest of
58	the City and its residents to utilize the City of Pompano Beach RFP E-13-17, Unleaded
59	Gasoline and Diesel Fuel for Southeast Florida Governmental Purchasing Cooperative
60	Group contract with Port Consolidated, Inc. to procure unleaded gasoline and diesel fuel
61	as budgeted for fiscal year FY 2016-2017.

63	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
64	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

66	SECTION 1. City Manager's Authorization. The Mayor and City
67	Commission hereby authorize the City Manager to utilize the City of Pompano Beach RFP
68	E-13-17, Unleaded Gasoline and Diesel Fuel for Southeast Florida Governmental
69	Purchasing Cooperative Group contract with Port Consolidated, Inc. to procure unleaded
70	gasoline and diesel fuel as budgeted for fiscal year FY 2016-2017. Further authorizing the
71	City Manager to execute all documents necessary to effectuate the expenditure of funds
72	for the project.
