5 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE
6 CITY OF HALLANDALE BEACH, FLORIDA, APPROVING MAJOR
7 DEVELOPMENT APPLICATION #DB-16-03057 FOR THE
8 CONSTRUCTION OF THE BLUESTEN PARK PROJECT AT 501 SE 1ST
9 AVENUE; PROVIDING AN EFFECTIVE DATE.

12 WHEREAS, the City is requesting approval of its Major Development Plan to develop the
13 Bluesten Park Project ("Bluesten Park") property located at 501 SE 1st Street, pursuant to Article
14 V, Section 32-787 of the Zoning and Land Development Code; and
15

16 WHEREAS, in 2007, the City purchased the Tower Mobile Home Park located at 600 Old
17 Federal Highway and the vacant lot at 601 Old Federal Highway for future expansion of Bluesten
18 Park; and
19

20 WHEREAS, in 2012, the two (2) parcels were rezoned to OS ("Open Space") District in
21 preparation for the redevelopment and expansion of Bluesten Park ("the Park"); and
22

23 WHEREAS, the proposed park will be expanded to incorporate the triangle parcel at 601
24 Old Federal Highway, east of the existing park; and
25

26 WHEREAS, the city proposes to build a forty six thousand seven hundred sixteen (46,716)
27 square feet community center, a two thousand two hundred sixty one (2,261) square foot pool
28 house, and a one thousand seven hundred eleven (1711) square foot concession stand; and

30 WHEREAS, the park will be expanded to include the triangle lot at 601 Old Federal
31 Highway. The rights-of-way dedications and variance applications will be concurrently reviewed
32 by the City Commission in conjunction with the proposed development; and

34 WHEREAS, the City Administration recommends approval of Bluesten Park with the
35 conditions enumerated in the staff report which accompanies this resolution, concluding that the
36 park is compliant with the City's Comprehensive Plan; and

39 **WHEREAS**, the Mayor and City Commission have determined that based on the
40 substantial competent evidence presented at a public hearing, the proposed major development
41 with City Administration's enumerated conditions, is in the best interest of the City, consistent with
42 the City's Comprehensive Plan, and will not adversely affect the public health, safety and welfare
43 of the City.

45 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
46 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

47 **SECTION 1. Approval of Major Development.** The Mayor and the City Commission of
48 the City of Hallandale Beach, Florida, hereby approve the Major Development Application #16-
49 o3057-DB, subject to the conditions enumerated in City Administration's report.

52 **SECTION 2. Effective Date.** This resolution shall be effective immediately upon its
53 adoption.
