16	WHEREAS, the City has applied for variances from certain code provisions in
17	order to accommodate for the size, purpose, and design of the Bluesten Park Project ("the
18	Project"); and
19	WHEREAS, the current location of the park is zoned Open Space District ("OS");
20	and
21	WHEREAS, the proposed project encompasses approximately seventeen (17)
22	acres of land with an aim to create a Town Center that is anchored by the park; and
23	WHEREAS, the proposed variances will reduce the amount of required trees to
24	three hundred twenty three (323) since the purpose of the park is to provide green space,
25	increase the amount of signage to accommodate four (4) signs due to the size of the park,
26	reduce the width of the right-of-way to accommodate the proposed community center
27	building, and reduce the landscape buffer to accommodate the proposed parking lot on
28	Southeast 7th Street; and
29	WHEREAS, on November 30, 2016, the Planning and Zoning Board reviewed the
30	application for major development review and rendered a recommendation of approval to
31	the Mayor and City Commission; and
32	WHEREAS, the City Administration has no objections to the City Commission
33	approving the variance application; and

WHEREAS, the Mayor and City Commission have determined that the proposed variance satisfies the goals and objectives of the Comprehensive Plan, as well as will not adversely affect the public health, safety and welfare, and therefore approve the applicant's variance; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

40 **SECTION 1.** Approval of Variance. The Mayor and City Commission of the City 41 of Hallandale Beach, Florida, hereby issue an order approving the variance application # 42 V-16-03686 as hereby attached as "Exhibit A" in accordance with Chapter 32, Sec. 32-43 965 of the City of Hallandale Beach Code of Ordinances to provide four (4) monument 44 signs, reduce the minimum amount of trees from four hundred fifty three (453) to three 45 hundred twenty three (323), reduce the landscape buffer strips from 10 feet to 8.5 feet, 46 and permitting two (2) signs which exceed the roofline.

47 <u>SECTION 2.</u> <u>Effective Date</u>. This Resolution shall take effect immediately upon
48 its passage and adoption.
