**A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
SETTING AND AMENDING FEES AND CHARGES FOR CITY  
SERVICES, APPLICATIONS, LICENSES AND PERMITS AND  
ADOPTING A FEE BOOKLET; AND PROVIDING AN  
EFFECTIVE DATE.**

**WHEREAS**, service, user charges and fees, are set and amended by Resolution; and

**WHEREAS**, the City Clerk has prepared a comprehensive booklet containing fees and charges to be effective for the 2015-16 budget year.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF  
THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1.** The "Schedule of Fees and Charges" dated October 1, 2015, which is on file with the City Clerk, is hereby adopted as the schedule of fees and charges applicable in the City of Hallandale Beach for all charges and services rendered by the City, on or after October 1, 2015.

**SECTION 2.** The City Manager is authorized to promulgate and publish such fees and charges and shall insure the proper collection and accounting of all monies arising therefrom. In the event of doubt or ambiguity, the City Manager is authorized to determine the appropriate fee.

**SECTION 3.** The City Manager is authorized to revise and amend the fee(s) and charges for City services, applications, licenses and permits from time to time.

**SECTION 4.** The City Manager is authorized to revise the appropriate fee(s) when additional fees or charges are required by Broward County or the Florida State Legislature.

**SECTION 5.** This Resolution shall take effect immediately upon its passage and adoption.
