15	order to allow a portion of the proposed school facility at 412 SW 11th Street to be
16	constructed at a height of twenty-eight feet (28) from that of twenty-five (25) feet which is
17	otherwise required by city code section 32-149 (d) (4); and
18	WHEREAS, the current location of the school facility is zoned Business Limited
19	District (B-L); and
20	WHEREAS, the proposed location for this project is on 1.21 acres. The proposed
21	school facility will consist of 25,022 square feet in gross floor area (GFA) with a portion of
22	the school facility to be built at a height of 28 feet, 2 stories high in order to allow for proper
23	ceiling clearance to accommodate infrastructure such as joists, ductwork, and utilities; and
24	WHEREAS, on March 22, 2017, the Planning and Zoning Board reviewed the
25	application for major development review and rendered a recommendation of approval to
26	the Mayor and City Commission; and
27	WHEREAS, the City Administration has no objections to the City Commission
28	approving the variance application; and
29	WHEREAS, the Mayor and City Commission have determined that the proposed
30	variance satisfies the goals and objectives of the Comprehensive Plan as well as will not
31	adversely affect the public health, safety and welfare, and therefore approve the
32	applicant's variance; and
