23	WHEREAS, the National Joint Powers Alliance (NJPA) is a public agency that
24	serves as a national municipal contracting agency, and it has the authority to develop and

28	NJPA cooperative purchasing contracts in order to provide cost savings and cost
29	avoidances that would otherwise be impossible for a City of our size to realize; and

32	the use of the NJPA NAPA contract in the amount of eighty thousand (\$80,000.00) dollars;
