14 15	(\$144,253.09); AND PROVIDING FOR AN EFFECTIVE DATE.

17	WHEREAS, the City is currently constructing the City's Main Fire Station and Emergency
18	Operations Facility; and
19	
20	WHEREAS, this facility is approximately 25,000 square feet and will house the Fire Station
21	living quarters, administration offices and Emergency Operations Center; and
22	
23	WHEREAS, the building is expected to reach substantial completion by July 31, 2017, a
24	which time, the Office of Capital Improvements will begin the installation of furniture and
25	equipment to support the station's operational functions, prior to the relocation of personnel; and
26	
27	WHEREAS, the Project's architect provided furniture layout as part of their design
28	development scope of services and recommended Krueger International Inc., an international
29	institutional furniture company with substantial experience in Fire Station Facilities and
30	Emergency Operations Centers; and
31	
32	WHEREAS, pursuant to Chapter 23, Section 23-8 (6), Exception to Bid Requirements
33	the City Manager is authorized to procure supplies, materials, equipment and services from othe
34	governmental units, when the best interests of the City would be served subject to the requiremen
35	that any purchase in excess of \$50,000 requires City Commission approval; and

37	WHEREAS, Krueger International, Inc. has active State of Florida contracts #420-420-10
38	1 and 425-001-12-1, which are available to be utilized by the City of Hallandale Beach for the

39 40	purchase of the necessary furniture in an amount not to exceed One Hundred Forty Five Thousand Three Hundred Eighteen Dollars and Fifty Two Cents (\$145,318.52); and

57	Forty Five Thousand Three Hundred Eighteen Dollars and Fifty Two Cents (\$145,318.52) and to
58	utilize the State of Florida contracts #420-420-10-1 and 425-001-12-1 with Krueger International,
59	Inc., to supply, deliver and install all furniture as per the proposed design of the City's Main Fire
60	Station and Emergency Operations Facility. The Mayor and City Commission further authorize
61	the City Manager to execute any and all necessary documents to facilitate said purchase.
